

# American Board-Certified Physicians: Requirements for Full Licensure

## PREAMBLE

The American Board of Medical Specialties (ABMS)<sup>1</sup> was established in 1933 and its board certification process requires an ongoing independent evaluation to ensure clinical competence and continuing professional development. Additionally, its process ensures the board-certified physician meets the standard of practice established by their peers.

Physicians holding certification with one of the Member Boards of the American Board of Medical Specialties may qualify for a Full licence.

## PURPOSE

This policy describes the minimum requirements to obtain a Full licence for American Board-certified physicians in specialties and subspecialties.

## SCOPE

This policy applies to physicians who currently hold certification in their respective specialty and/or subspecialty with one of the Member Boards of the American Board of Medical Specialties.

## POLICY

## **Eligibility Criteria**

## 1. Credentials

Candidates must have all of the following credentials:

Credential	Description
Medical Degree	Applicants must have a recognized medical degree from a school listed in the World Directory of Medical Schools <sup>2</sup>
Postgraduate Training	Applicants must have completed their postgraduate training in the United States of America (USA)*.
	*Applicants holding American Board certification who <b>did</b> <b>not</b> complete their postgraduate training in the USA may be eligible for a Full licence at the discretion of the Registrar.
LMCC or acceptable alternative	Applicants must be a Licentiate of the Medical Council of Canada (LMCC) <sup>3</sup> or have one of the College's acceptable alternatives to the LMCC <sup>4</sup>
Certification	Applicants must have current certification with any of the Member Boards of the American Board for Medical Specialties (ABMS)

## 2. <u>Requirements of Licensure</u>

## i. Letter of Offer or Confirmation of Privileges

Physicians who meet the above eligibility criteria must provide the College with a letter of offer **OR** confirmation of privileges with Nova Scotia Health or the IWK Health Centre in Nova Scotia before their licence will be issued.

## ii. Continuing Professional Development

The College will accept annual confirmation of a physician's certification status with the respective American Board as proof of satisfactory participation in a continuing professional development program.

If the physician does not maintain their certification status with the relevant American Board, the physician is required to adhere to the College policy for *Continuing Professional Development: Requirements*<sup>5</sup>.

## iii. Scope of Practice

As with all physicians, the physician must practise within the scope for which they have the current knowledge, training, skills and recent practice experience.

The physician must meet the College's currency of practice experience requirements<sup>6</sup> for practice.
