

# Subspecialist Examination Affiliate Program (SEAP) Designates: Requirements for Full Licensure

## PREAMBLE

The Royal College of Physicians and Surgeons of Canada (the Royal College)<sup>1</sup> offers a Subspecialist Examination Affiliate Program (SEAP)<sup>2</sup> for subspecialists who have not successfully completed the certification examination in their primary specialty.

Upon successful completion of the Royal College subspecialty examination through this program, the physician can become a Subspecialist Affiliate with the Royal College.

Physicians with Royal College Subspecialist Affiliate status may be eligible for Full licensure.

#### PURPOSE

This policy outlines the eligibility criteria for Full licensure for physicians who hold Royal College Subspecialist Affiliate status.

#### SCOPE

This policy applies to physicians who are trained in a subspecialty and have successfully obtained Subspecialist Affiliate status with the Royal College.

#### POLICY

Physicians with Subspecialist Affiliate status who otherwise qualify for licensure may qualify for a Full licence to practise the relevant subspecialty.

Candidates must not be prohibited or restricted from practising medicine through the decision of any adjudicating body or through voluntary agreement or otherwise (other than by conditions or restrictions imposed on a licence by a regulator).

## **Eligibility Criteria**

## 1. Credentials

Candidates must have all of the following credentials:

Credential	Description	
Medical Degree	Medical degree from a school listed in the World Directory of Medical Schools <sup>3</sup> .	
Medical Council of Canada (MCC)	Be a Licentiate of the Medical Council of Canada (LMCC) <sup>4</sup> or qualify for an Acceptable Alternative to the LMCC <sup>5</sup> .	
Confirmation of Postgraduate Training	A certificate of completion of training or letter confirming completion of training.	
Subspecialty Recognition	Must have Royal College of Physicians and Surgeons of Canada Subspecialist Affiliate status through the Subspecialist Examination Affiliate Program (SEAP)	

## 2. Requirements of Licensure

#### i. Letter of Offer or Confirmation of Privileges

Physicians who meet the above eligibility criteria must provide the College with a letter of offer **OR** confirmation of privileges with Nova Scotia Health or the IWK Health Centre in Nova Scotia before their licence will be issued.

## ii. English Language Proficiency

In accordance with Section 39 of the Medical Practitioners Regulations, candidates are required to demonstrate proficiency in the English language, in a manner prescribed by the Registrar.

All physicians must have the ability to effectively communicate with patients, other professionals and the College as described in the College policy on *English Language Proficiency*<sup>6</sup>.
